

Promotion Terms & Conditions

"Promotion Period" means the period during which the applicable promotional offer is valid, as identified in the promotion details published by Cygnus Atratus Arms Corp., unless extended, modified, suspended, or terminated by Cygnus Atratus Arms Corp.

Promotion

The applicable promotional offer, including any discount, qualifying products or services, promotional code requirements, exclusions, and redemption conditions, will be identified in the promotion details published by Cygnus Atratus Arms Corp.
